Entity's Purpose or Mission

The aims and objectives of Friends of Hamilton Gardens Inc are

- to promote public awareness, use and enjoyment of Hamilton Gardens,
- to raise funds and assist Hamilton City Council with the development of the Gardens,
- to promote, organise and encourage appropriate events at the Gardens,
- to promote Hamilton Gardens as a tourist attraction, and
- to conduct such activities as will promote membership of the Society and support its activities.

Entity Structure

At the Annual General Meeting, members of the Society elect a committee which includes a President, Vice-President, Immediate Past President, Secretary, Treasurer and up to seven elected members, together with the Director of the Hamilton Gardens in an ex-officio capacity. The committee has power to co-opt members for specific purposes.

Main Sources of Entity's Cash and Resources

The Society relies on member subscriptions to cover operating costs. Hamilton City Council pays an annual contribution in return for the Society providing volunteers to attend the visitor centre and carry out guided tours. Public donations from visitors made via donation boxes at Hamilton Gardens are used to support development projects at Hamilton Gardens.

Main Methods Used by Entity to Raise Funds

Member subscriptions, public donations, Hamilton City Council payment for Volunteer services, plant sales and events.

Entity's Reliance on Volunteers and Donated Goods or Services

The Society relies on volunteers for activities and fundraising activities. The committee members volunteer time to set policy, attend meetings, produce newsletters and an annual journal, to organise social events for members, organise fundraising events, and manage finances. Member volunteers staff the Visitor Centre at the Hamilton Gardens and provide guided tours of the Gardens. Members also work on propagation and plant sales, making preserves for sale and other fundraising activities.

Statement of Accounting Policies

Friends of Hamilton Gardens Inc For the year ended 31 July 2025

'How did we do our accounting?'

Basis of Preparation

The entity is permitted by law to apply the Tier 3 (NFP) Standard issued by the External Reporting Board (XRB) and has elected to do so. A PBE may apply the standard if it does not have public accountability and has total annual expenses less than or equal to \$2,000,000. All transactions in the Performance Report are reported using the accrual basis of accounting. The Performance Report is prepared under the assumption that the entity will continue to operate in the foreseeable future.

Goods and Services Tax (GST)

The entity is registered for GST. All amounts are stated exclusive of goods and services tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

Income Tax

Friends of Hamilton Gardens Inc is wholly exempt from New Zealand income tax having fully complied with all statutory conditions for these exemptions.

Bank Accounts and Cash

Bank accounts and cash in the Statement of Cash Flows comprise cash balances and bank balances (including short term deposits) with original maturities of 90 days or less.

Property Plant and Equipment

The property plant and equipment of the Society are recorded at cost less accumulated depreciation. These values are recorded in the Property Plant and Equipment at Note 4. The following depreciation rates have been applied:

- Furniture and Fittings Straight Line over 10 Years
- Computer Equipment Straight Line over 4 Years

Revenue Recognition

Revenue is recognised to the extent that it is probable that economic benefit will flow to the Society and revenue can be reliably measured. Revenue is measured at fair value of the consideration received. The following specific criteria are applied before revenue is recognised.

Donations, Fundraising and other similar revenue

Donations are recognised as revenue upon receipt.

Grant revenue includes grants given by other charitable organisations, government controlled entities and independent businesses. Grant revenue is recognised when the conditions attached to the grant have been complied with. Where there are unfulfilled conditions attaching to the grant, the amount relating to the unfulfilled condition is recognised as a liability and released as the conditions are met.

Revenue from legacies and estates that satisfy the definition of an asset is recognised as revenue when it is probable that future economic benefits or service potential will flow to the Society, and the fair value can be reliably measured.

Revenue from providing goods and services

The entity receives revenue from its members and the community by way of subscriptions and product and event sales. Revenue is recognised in the period the goods or services are provided.

Interest

Interest revenue is recognised as it accrued, using the effective interest method.
